# Legislative Updates

- November Midterm Elections
  Democrats could lose slim majority
- FY 2023 Budget Biden's Blueprint Requests 15 percent boost to ED spending \$2,175 increase to Pell Grant \$752 million boost to low-resourced colleges
- Congress passes Continuing Resolution
- American Data Privacy and Protection Act (ADPPA)
  Comprehensive federal data privacy bill would preempt most state laws.
  Proposal includes a number of problematic provisions related to information regulated by FERPA. Stalled in committee.





### Veterans & Service Member Issues

 Ensuring the Best Schools for Veterans Act Address concerns from Dept. of VA's recent policy changes to the 85/15 rule Clarifies the 35 percent exemption, restoring it to its original intent Corrects the negative impacts of the new interpretation of what constitutes a "supported student" for 85/15 purposes

# Other Federal Updates

- FAFSA simplification implementation
- Biden's Student Loan Debt Relief Plan \$10,000 for those earning less than \$125,000 with an additional \$10,000 for Pell Grant recipients
- Supreme Court Admissions Cases Justices heard two cases involving the race-conscious admissions policies at Harvard and UNC Chapel Hill
- AACRAO Submits Amicus Brief Informs the Court of the importance of continuing to allow admission professionals to holistically review all factors regarding applicants.





# Regulatory Update


• Earlier this year, the Education Department wrapped up its negotiated rulemaking process on **institutional and programmatic eligibility**, reaching consensus on two of the seven regulatory proposals.





# Regulatory Update

• Education Department also concluded rulemaking on **affordability and student loan rules**, reaching consensus on four issues. The committee failed to agree on the remaining, more contentious plans.
