







Over the past two years, State Regents' staff and advisory committees have reviewed and revised policies to incorporate current APA rules and to increase readability and clarity. Some policies have been added or substantively revised as recommended by advisory committees or as needed to reflect current practice. The proposed revised manual is organized into five chapters corresponding to major functions of the State Regents (Governance, Administrative Operations, Academic, Budget and Fiscal, and Student Financial Aid and Scholarships).

Every policy in the manual follows a standard format and numbering system to allow staff, institutions and the public to more easily find information and locate citations.

BACKGROUND

- ➤ Began in December 2022 under request by Chancellor
- **→**Guiding principles:
 - ➤ Remove barriers to success;
 - ➤ Emphasize quality and raise standards, but reduce the steps to achieve those standards;
 - ➤ Simplify language and remove statements that are not policy;
 - ▶ Promote efficiency and collaboration;
 - ➤ Align with state statutes and accreditation standards;
 - ▶ Foster innovation and speed to react to changing workforce needs;
 - ➤ Reduce time spent on processes that don't impact outcomes; and
 - ➤ Eliminate requirements that cost more than the benefits they provide.





 - No changes
 - ➤ Section B Curricular Deficiencies
 - ➤ Eliminated language
 - ➤ All students with curricular deficiencies can be admitted using alternative admission category
 - ➤ Must complete within 24 college credits
 - > Section C
 - Removed

 - ➤ Eliminated requirement that GED recipients high school class must have graduated
 - ▶ Removed language already mentioned in Grading policy

 - ➤ Added for Langston and USAO

 - ▶ Removed ACT requirement

 - ➤ Students limited to 3 attempts to improve grade
 - > Highest grade earned to be used in GPA calculation
 - ➤ If most recent repeated course was graded as pass-fail, then the pass-fail grade is used and none of the previous letter grades apply.
 - ➤ No limit in attempts to achieve degree/program/course requirements
 - ➤ Highest grade earned to be used in GPA calculation

- ▶3.12.5 Academic Forgiveness Provisions (cont.)
 - ▶ Academic Reprieve
 - ➤ Removed the 3-year restriction to request a reprieve
 - ▶ Academic Renewal
 - ➤ Changed timeframe from 5 years to 3 years
 - ➤ Allow shorter timeframe with approval by Chief Academic Officer

- ➤ Ability for honorary degrees to be revoked with governing board approval
- ▶ Removes State Regent approval for exceptions to award honorary degrees in absentia or posthumously

 - ➤ Change requirement to award from last semester to completion of at least two-thirds

 - ➤Added evaluation of student's military service transcripts or training documents

 - ➤Added use of systemwide credit for prior learning assessment inventory for:
 - ➤ Industry recognized credential

 - ➤ Removed language regarding AP scores that is statutorily required
 - ➤ No longer requires AP Exam policy to be posted on institution's website

 - ➤ Section A Online Program Design
 - ➤ Course Development Requires institutions to have defined standards for quality, offer faculty support, and ensure courses meet accessibility standards.
 - ➤ Advertising Must provide expectations for any face-to-face or on-ground requirements, services available, and professional licensure disclosures
 - ➤ Equipment and software/tools Provide accurate information regarding technology requirements
 - ➤ Section B Online Teaching Support
 - ➤ Faculty Development Requires institutions to provide training to both full and part-time faculty
 - ➤ Continuous Improvement Requires process to collect and use learner feedback to inform improvement
 - Train faculty on copyright and intellectual property
