# Changes to the Bylaws & Constitution

- For two years (2020-2022), former OACRAO President Janet Kelley worked diligently with the Executive Committee to update the OACRAO Bylaws and Constitution
- These proposed changes are mostly "housekeeping" changes, ones that consolidate and clarify items and policies to make the execution of OACRAO easier and more attainable
- Each of the proposed changes are as follows...

# **OACRAO Bylaws**

- The last change to the OACRAO Bylaws was made on October 6, 2017
- The only proposed change today is to Article V, Paragraph 4:
  - Current: "Every five years, the association's executive committee is responsible for seeking a comprehensive financial review from a certificated public accountant to ensure the organization is complying with federal and state tax laws."
  - Proposed: "Every five years (ending in 0 and 5), the association's executive committee is responsible for seeking a comprehensive financial review from a certified public accountant to ensure the organization is complying with federal and state tax laws."

#### **OACRAO** Constitution

- The last change to the OACRAO Constitution was made in 2020 (we believe),
   but previous changes from 2014 and 2018 might not have been recorded.
- The following changes to the OACRAO Constitution are as follows...

Article III. Membership

Institutional Membership

- Current: "Any two-year or four-year degree-granting institution in the state of Oklahoma (accredited by the Higher Learning Commission of North Central Association of Colleges and Schools) shall be eligible for membership."
- Proposed: "Any two-year or four-year degree-granting institution in the state of Oklahoma (accredited by the Higher Learning Commission of North Central Association of Colleges and Schools) shall be eligible for membership."

Article IV. Officers

#### Section 5

Change "Drive-In Workshop" to "Summer Frontline Workshop"

#### Section 6

- Current: "The secretary shall serve for a two-year term with the term expiring in alternating years with the treasurer."
- Proposed: "The secretary shall serve for a two-year term with the term expiring in alternating even numbered years with the treasurer."

Article IV. Officers

#### Section 7

- Current: "The treasurer shall serve for a two-year term set in even numbered years and expiring in alternating years with the secretary."
- Proposed: "The treasurer shall serve for a two-year term set in even odd numbered years and expiring in alternating years with the secretary."

Article V. Committees and Representatives

#### Representatives

- Current: "The president or past-president (or president's designee) shall serve as the state representative to SACRAO, who shall be responsible for attending the SACRAO annual meeting and reporting all pertinent information to the executive committee and the membership."
- Proposed: "The president or past-president (or president's designee) or
  executive committee member if necessary by majority vote of the current
  executive committee shall serve as the state representative to SACRAO, who
  shall be responsible for attending the SACRAO annual meeting and reporting all
  pertinent information to the executive committee and the membership."
